

The Cooperation Agreement  
Between

Department of Sociology, Chung-Ang University  
Republic of Korea

And

International Institute for Cultural Studies,  
Institute of Social Research and Cultural Studies,  
International Master's Program in Inter-Asia Cultural Studies,  
National Chiao Tung University, Taiwan

**ARTICLE ONE**

*Department of Sociology at Chung-Ang University and International Institute for Cultural Studies, Institute of Social Research and Cultural Studies, International Master's Program in Inter-Asia Cultural Studies at National Chiao Tung University agree to cooperate in the following:*

- Faculty exchange
- Student exchange
- Exchange of teaching materials
- Joint research projects
- Conferences
- Co-supervision for thesis

**ARTICLE TWO**

Both parties are committed to fostering joint projects in the field of education and research and are open to any form of potential cooperation.

**ARTICLE THREE**

Both parties agree that specific details of cooperation necessary to implement this agreement must be negotiated by written agreement with each other.

**ARTICLE FOUR**

In the case of student exchange, the student must pay tuition of the Home University.

**ARTICLE FIVE**

In the case of semester studies, student exchange shall be realised at the university level. In the case of seminars or independent studies, student exchange shall be realised at the level of Faculties or Units.

**ARTICLE SIX**

Exchange shall be realised on the basis of cooperation of the Faculties or Units.

**ARTICLE SEVEN**

Department of Sociology on behalf of Chung-Ang University and International Master's Program in Inter-Asia Cultural Studies on behalf of National Chiao Tung University are responsible for coordination of all activities related to implementation of this agreement.

**ARTICLE EIGHT**

The agreement shall come into force when signed by legal representatives of both parties and shall remain valid for three (3) years and may be modified or revised by mutual written consent of the two parties.

**ARTICLE NINE**

Either parties may, by prior notice in writing of no less than 6 months, terminate this agreement. The exchange activities that have been commenced under this Agreement shall not be affected by the termination thereof.
